<u>The minutes</u> from the March 13, 2018 Executive Board Meeting had one correction. M. A motion was then made by L. Kenney and seconded by R. Longfellow to approve the corrected minutes; the motion carried.

<u>The Treasurer's Report</u> presented by L. Kenney. The balance of the Checking Account is \$7673.44, the Memorial Fund Balance is \$1735.81, and the Life Account Balance is \$7643.68. Total assets as of June 6, 2018 are \$17,214.15. Dues are still being collected. P. Bratta moved and R. Longfellow seconded that the report be approved; the motion carried.

<u>Legislative-</u> Among the highlights in this IL budget session were the following:

- a new funding formula that ensures every school district will see an increase in funds
- a \$50 million increase for Early Childhood programs
- continued State support for Retired Teacher Health Insurance (TRIP)

Voluntary Pension Reforms include:

- 1. COLA buyout: Tier 1 employees owed a compounding 3% COLA in retirement would get the option of having the State buy out the compounded COLA for 70% of the value.
- 2. Pension spiking: end-of-career raises would be limited to 3% (currently 6%). School districts awarding end-of-career raises in excess of 3% would be charged to cover the increased expense to state taxpayers.

<u>Call Coordinator-</u> Marvel Blomberg reported that reservations for the July meeting need to be to her by June 30.
