## Ogle-Lee Retired Teachers' Association Meeting – July 9, 2019

The summer luncheon membership meeting of the Ogle-Lee Retired Teachers' Association was held on Tuesday, July 9, 2019 beginning with a social hour at 11:00 AM, business meeting at Noon, lunch at 12:40 PM, and the program after the meal at the Amboy Community Building. The treasurer's report as of June 10, 2019 was accepted by consensus as prepared by Treasurer Linda Kenney. The checking account balance was \$8,598.64, the Memorial Account balance was \$260.81, and the Life Account balance was \$7,735.72. Total assets were \$16,595.17.

Legislative Chairperson Kim McKenna updated members on state legislation pertaining to education and the state budget. She also announced her resignation as legislative chair.

The IRTA State Convention will be at the Springfield Crown Plaza on October 14-15, 2019. More information and reservation forms are on the IRTA website. Ogle-Lee RTA will prepare a Silent Auction Basket with donations going to the Political Action Fund. Members were encouraged to donate any locally produced items for the "Made in Ogle-Lee County" basket.

It was announced that Cody Suddeth from Steward, IL (Ogle-Lee Unit area) is a state IRTA scholarship winner and will study Agricultural Education.

Nominations for Ogle-Lee RTA officers were taken at the July 9, 2019 membership meeting and voting will take place at the October 8, 2019 membership meeting. Treasurer Linda Kenney and Secretary Elke Grennan agreed to run again for their respective office. Nominations for president (or co-presidents) and vice-president (or co-vice presidents) will be accepted up to the October 8 election. There are also openings for legislative chairperson, historian/necrology, calling coordinator, webmaster, and assistant webmaster. Interested members for any of these positions should contact the co-presidents.

Association Member Benefits Advisors (AMBA) representative Nancy Cramer provided a handout of benefits available to members and discussed AMBA's role in recruiting members for IRTA.

Gail Tuttle from Habitat for Humanity of Ogle County explained how they build both new houses and also do smaller projects called "Brush with Kindness" to help low income families take pride in owning their home.

Co-Vice President Diane Kenney spoke of the importance of keeping the Ogle-Lee Unit of IRTA strong as IRTA is the only organization solely devoted to protecting Illinois teacher pensions and TRIP/TRAIL insurance.
