#### Message from Kim McKenna, Ogle-Lee RTA President

Summer shows signs of moving towards fall as a new school year begins.

For those of you who will be or are considering being a substitute teacher this year, that these laws are now in effect: short term substitute teachers may work 15 consecutive days in a classroom instead of five. The fee for renewing a lapsed teaching license dropped from \$500 to \$50. The registration fee for retired teachers who want to renew their license has been waived.

As of this writing, I have not received any further information from IRTA concerning Central Management Services changing the provider for the TRAIL insurance program from United Health Care to Aetna or how this will impact benefits or access to benefits for retired teachers.

The redistricting maps in the state have changed the Illinois Senate and House districts in our counties. The districts and candidates in the upcoming November election are:
