Legislative Update March 2019

In his budget address, Governor Pritzker proposed to reduce the state contributions to TRS by almost six hundred million dollars. Governor Pritzker based this reduction on his anticipated legislation that would add seven years until the state is required to fund the pension at the 90% level. He is also anticipating savings from an extension of a

buyout program that was passed last year, but never put in place. The Governor did propose increasing assets through a combination of bonding and asset sales, and to increase the contributions to TRS with a proposed two hundred million dollars once his graduated income tax is passed. At this time, it is impossible to know the full extent of the cost of the proposed budget to the State of Illinois until TRS performs an analysis. Although it has not been proposed, IRTA remains steadfast in NOT supporting taxing of retirement income.

The Governor did propose to fully fund the amount for the Teacher's Health Insurance Fund which will allow TRIP to continue to offer benefits similar to current benefits. The Governor also proposed increasing funding for education and for providing funding for new initiatives.

On a different note, Doug Strand is the IRTA endorsed candidate for TRS Annuitant Trustee. IRTA considered several candidates and felt that Doug Strand was the best person for the job.
