Don't forget that if the state gets away with reducing our COLA, it opens the door to future reductions of our benefits which are guaranteed by the state and federal constitutions.

Legislative Update June 2018

The Illinois State operating budget totals \$38.5 billion, which is an increase of over \$600 million from the current budget. The increase is largely due to increases in education funding and making required pension payments.

Highlights of the budget include:

- \$350 million increase in K-12 funding ensuring every school district will see an increase.
- \$50 million increase in early childhood programs.
- State support for the retired teachers health insurance program(TRIP).
- Higher education receives 2% increase.
- A series of voluntary pension reforms include: COLA buyout; Tier 1 employees have the option of having the state buyout the compounded COLA for 70% of the value. Pension spiking: End of career raises would be limited to 3%, currently 6%. If school districts award end of year career raises in excess of 3%, the school district would be charged to cover the increase expense.
- The \$1 billion budget deficit will be closed through savings, reforms, and using other available revenues.
- The state is authorized to utilize up to \$800 million in existing various state accounts and pay it back over the next two years

The budget won Senate approval 56-2 and passed the House 97-18.
